

FINAL EVENT TERMS AND CONDITIONS – Australian Series of Beer Pong – Summer Season Final at Beach Road Hotel, Bondi (30/3/14)

1. Rules & Terms

- a. All standard Australian Series of Beer Pong Terms & Conditions will apply as listed below, some points to high light are:
 - i. If you become intoxicated you will be asked to leave the tournament, with no refund. This will be at discretion of staff of Beach Road Hotel, Bondi and ASOBP Staff
 - ii. If there is threatening or abusive behaviour you by any participant you and your team mate will be ejected from the tournament at the discretion of venue management and ASOBP staff
- b. 1st Prize is guaranteed \$1000.00 Cash, participants must be over 18 years old to claim prize
- c. Give Away of ASOBP Merchandise pack worth \$250.00 will be done prior to the final. It will be drawn at random from all names who have played in the event
- d. 52 teams is the current sell out amount. ASOBP reserves the right to increase this level to 75 teams if demand is sufficient.
- e. In playing the Australian Series of Beer Pong – Summer Season Final (30/3/14) you agree to all Australian Series of Beer Pong to use your image for advertising purposes
- f. The first 40 teams of each state (NSW & QLD only) to pay for a full priced entry ticket will receive one (1) case of 24 stubbies of 4 Pines beer FREE of charge. The case of beer will only be redeemable after the competition of the finals is complete and will be distributed by ASOBP staff.
- g. There is zero commercial value to the supplied beer.
- h. All RSA and appropriate intoxication laws will apply in regards to any alcoholic beverage giveaway.
- i. Persons must provide government approved ID, and be 18 years or older to be eligible for giveaway.
- j. ASOBP reserves the right to change the entry conditions and prizes available without notice.
- k. Due to any unforeseen circumstances out of the control of ASOBP, this event may be cancelled with little or no notice. In the event the tournament is cancelled, we will offer a full refund to any paying entrant. There will be no free giveaway prize offered under these circumstances.

1. Membership

- a) Australian Series Beer Pong PTY LTD (ABN 87 169 198 270) (ASOBP) administers the Australian Series of Beer Pong Membership Program.
- b) The "establishment" is the licensed establishment where you have joined the ASOBP program.
- c) Members of the ASOBP Membership Program must be over the age of 18 and an Australian resident. ASOBP may ask you at any time to provide valid identification to prove your eligibility to be a member of ASOBP.
- d) To apply for membership of ASOBP you must fully complete and sign the ASOBP membership application form. By signing the ASOBP membership application form you acknowledge that you have read and agree to be bound the terms and conditions and membership charter of ASOBP. ASOBP may from time to time amend these terms and conditions. A current copy of the terms and conditions will be displayed at www.asobp.com.au
- e) ASOBP or the establishment have the right to refuse any membership application at their sole discretion.
- f) Only one membership per person is permitted at each establishment.
- g) ASOBP administers other membership programs and reserves the right to combine, consolidate or re-brand any of the membership programs. In the event that ASOBP combine, consolidate or re-brand ASOBP all current members of ASOBP will automatically become members of the new membership program.

2. ASOBP Membership Cards

- a) Only one ASOBP member card per establishment will be issued. ASOBP membership cards remain the property of ASOBP. An ASOBP membership card is non-transferable and cannot be used by any person other than who the card is issued to.
- b) By using the ASOBP membership card you indicate your continuing acceptance of the terms and conditions of ASOBP as amended from time to time.
- c) If you lose your ASOBP membership card you must provide identification to receive a replacement card. You may be charged a fee of \$3aud for a replacement card.
- d) ASOBP & the establishment may at any time require you to provide valid identification to verify your membership or age.

3. Partners

- a) From time to time ASOBP will enter into partnership arrangement with other companies.
- b) By joining ASOBP you allow ASOBP to register your details with ASOBP partners. These partners may then offer you the opportunity to become a member of their respective programs. It is at your discretion to accept or decline these offers.

4. Use of Information/Privacy

- a) By becoming a member of ASOBP, unless otherwise advised, each member agrees that ASOBP may use your personal information for future promotional, marketing and publicity purposes without seeking your approval.
- b) ASOBP may also use information gained about members for research to develop future products, services and offers.
- c) Subject to clause 4(b) all information accumulated by ASOBP is for the use of ASOBP. ASOBP undertakes not to sell member information to any other person or organization that is unrelated to ASOBP.

5. Points

- a) ASOBP may from time to time conduct promotional activities that entitle members to reward points.

6. Competition

- b) Any member of ASOBP that participates in any ASOBP competition agrees to abide by the ASOBP member rules and code of conduct.

7. Liability

- a) ASOBP accepts no liability what so ever. All members agree to sign and abide by the membership agreement prior to playing in any tournament run by ASOBP.
- b) Any person who uses any ASOBP equipment, or participates in any organised event, gives implied consent, and will be treated with such regard.
- c) All members agree that ASOBP will store in digital form, an agreement between the participant and ASOBP. By becoming a member and signing the legal waiver, you are waiving your rights to sue both ASOBP or any of the executives or directors of the company, or staff participating in the running of any given event
